# **Spring 2015 Bulk Collection**

Bulk Collection days for spring 2015 have been scheduled for:

The collection will be at the Township building located at 1145 Garver Lane in the village of Scotland. This service is provided to the residents (not commercial) of Greene Township from the Supervisors.

Residents should bring driver's license as a form of identification or have a Greene Township identification sticker on the vehicle. A bulky item is an item that will not fit in your garbage container or weighs more than 50 pounds. Bulky items must be free of all garbage. Building materials, loose material, and items that can be broken down to fit in a garbage container are not bulky items and will not be accepted.

Please do not bring liquefied paints, spray cans, fuel drums, and other hazardous materials. We are unable to accept them. In addition, **construction debris will NOT be accepted**. Arrangements need to be made with the landfill to dump construction debris. We will accept items not picked up by your regular trash service but we **do NOT accept regular household trash (bags of garbage, recyclables, etc).** Yard waste is also not accepted during bulk collection. Greene Township accepts yard waste on a regular basis at our composting facility on Mickey Inn Road.


**ELECTRONIC RECYCLING**: We will be accepting "covered" electronic devices this spring. Covered devices include: desktop computers, laptop computers, computer monitors, computer peripherals & televisions.

**NOTE**: Vehicle batteries will be accepted again. We continue to accept 20 lb. propane bottles as well as up to eight tires per household for disposal. We can only accept standard car or pick-up truck tires. Rims and tires must be separated.

# Spring Brush & Leaf Collection

Greene Township will be commencing brush and leaf collection this spring beginning on the following dates:





The brush and leaves must be placed for pickup on the first day of their respective collection schedules. The collection crew will make ONE pass through the Township. Please place your brush and rake your leaves to the edge of your yard, no further than 4 feet from the edge of the pavement of the road. Do not bag your leaves. Brush should be no longer than 8 feet in length and no bigger than 3 inches in diameter. The brush and leaves must be on separate piles in order for the Township machinery to collect it. If the brush and leaves are not separated, they will not be collected. Please avoid placing brush and leaves next to mailboxes, fence posts, etc. as they can be damaged by the equipment.

# **Composting Facility**



We would like to remind residents that Greene Township has implemented a new procedure for purchasing mulch and compost at our Composting Facility. Residents of Greene Township are required to obtain a prepaid card called a "Greene Card". Two types of Greene Cards are available. A \$10 card for one use only and a \$50 card which will afford the card holder five uses at the Composting Facility. Each "use" is equivalent to one bucket load of mulch or compost.

You may purchase Greene Cards at the Greene Township office located at 1145 Garver Lane in Scotland during our regular business hours – Monday thru Friday, 8:00am to 4:00pm. Simply present a photo identification confirming you reside within the Township. Non-residents are not authorized to use the facility. A Greene Card will not be replaced if lost or stolen.

Greene Cards will <u>not</u> be available for sale at the Composting Facility, only at the Township office, and only during business hours. Staff will punch each \$50 Greene Card for each use at the facility. Once a card is punched five times it will be destroyed. A \$10 card can be used once and will be collected after its use.

## **Earthmoving Activities**

Information from the Conservation District. Over the last several years the Conservation District has educated the municipalities, developers, builders and contractors on the State's requirements for earth moving. The one group we have not focused on is the individual landowners. They usually learn about us after they've started an activity and the District receives a complaint and we investigate. The landowner comes to find out they are in violation of the State's Regulation for earthmoving.

The Conservation District tries to work with the landowner one on one guiding them on what they need to do. If the area of disturbance is 5,000 sq. feet, a person needs to install some type of erosion control (E&S) best management practice (BMP). Such as straw bales, silt fence, filter sock, and then properly stabilize the activity with seed and straw mulch.

If the activity is over 5,000 sq. feet then a plan drawing is required showing what the activity is and what erosion control measures will be installed prior to the activity starting and indicate how the activity will be stabilized.

Finally, if the activity is 1 acre or more, then the Federal Construction Permit called the National Pollutant Discharge Elimination System (NPDES) Permit is required. This permit requires the applicant to have and implement E&S control measures during construction and how the Stormwater will be treated in the activity's final condition. Often this type of project requires an engineer to go thru the calculations that are needed for the Stormwater aspect of the permit.

If you are currently wanting to buy a lot in a subdivision, you will be required to have E&S measures and some type of Stormwater Control measure on your lot to treat the Stormwater such as (amended soils, rain barrel, rain garden, infiltration trench, etc.) and it will be your responsibility to maintain as long as you own the lot.

Farmers are also regulated. The State's regulation on farming requires all farming operations to have an Agricultural Erosion and Sediment Control (AG E&S) plan. OR if the operation is just animals to have a Nutrient Management or a Manure management plan. Even a landowner who just has a horse, goat, alpaca, etc. is required to have a manure management plan.

## **Clean Up After Your Pet**

The Greene Township Board of Supervisors would like to remind residents and property owners and in particular, pet owners, Section 45-4 of the Greene Township Code states:



- "... a dog owner or cat owner shall be presumed to have created or maintained a nuisance if he shall permit his dog or cat to defecate or urinate:
- 1) Upon any street, sidewalk, passageway, park or any other public place where people congregate or walk; or
- 2) Upon any private property of another person without the permission of the owner of said property unless, with regard to defecation only, such dog owner or cat owner shall immediately remove and dispose of in a sanitary manner all feces deposited by such dog or cat."

Besides the unpleasant smell and unsightly appearance, animal waste can be hazardous to the health of the children in our community and other pets as well. Disease can be transmitted to dogs, cats and people through feces. When walking your pet please clean up after your pet. Take along a baggie to pick up waste and then dispose of it properly. If you're visiting our park with your pet, waste stations are located throughout the park.

As a pet owner it is not only a courtesy to your neighbors to clean up after your pet but it is also your responsibility. Keep our community safe and clean. Your neighbors will appreciate it.

## **Septic Tank Pumping**

We would like to remind residents that **District 1** septic tank pumping is required this year as part of our sewage management program. District 1 is located in the Western portion of the Township. All septic tanks in the Township are required to be pumped and inspected every three (3) years by a licensed pumper / hauler.
