
Can You Identify This Picture?

Statewide Building Code In 2004

The regulations for the statewide building code that was passed in 1999 are now in their final form. After being passed by the state legislature and signed by Governor Ridge, the statewide building code has gone through a long process of drafting and revising

The code, which provides standards to regulate commercial **and** residential construction, will take effect statewide no later than August 7

As always if you are building in Greene Township, please contact the Greene Township Zoning Office at (717)263-4990 to find out what regulations you will need to meet The Greene Township Zoning Office will continue to issue permits that certify compliance with the Greene Township Zoning Ordinance. Once the statewide building code has taken effect, you will also be required to get a building permit and have related inspections to certify compliance with the statewide building code The Greene Township Board of Supervisors and staff will do our best to assist you through this process

Current permits issued by our Zoning Office are good for eighteen months. If Greene Township's permit is issued prior to the statewide building code implementation, your structure will be exempt from the building code's regulations.

Accessory structures under 500 square feet will also be exempt from building code regulation

Spring 2004 Bulk Collection

Please note the corrected date!

Bulk Collection days for spring 2004 have been scheduled for Friday and Saturday, April 23 & 24, 2004 The collection will be at the Township building located at 1145 Garver Lane in the village of Scotland The collection on Friday will begin at 7:00 AM and will finish at 3:00 PM. The collection on Saturday will begin at 6:00 AM and will finish at 4:00 PM. This service is provided free of charge to the residents of Greene Township from the supervisors Please inform your neighbors and friends of this service and encourage them to participate

Please do not bring batteries, liquefied paints, spray cans, propane bottles, fuel drums, and other hazardous materials. We are unable to accept them In addition, construction debris will not be accepted. Arrangements need to be made with the landfill to dump construction debris. We will accept items not picked up by your regular trash service but we do not accept regular household trash. Yard waste is also not accepted during bulk collection. Greene Township accepts yard waste on a regular basis at our composting facility on Mickey's Inn Road.

Please contact the Greene Township Board of Supervisors at (717) 263-9160 with any questions regarding our upcoming bulk collection days.

NOTE: Once again, we will accept tires. We will accept up to eight tires per household for disposal at bulk collection days this fall. We will only accept standard car or pick-up truck tires. No rims are allowed.



Greene Township Office Expansion




Judge Meminger's office suite will be housed at Greene Township and his courtroom will also serve as the new meeting room for the Greene Township Board of Supervisors
