The meeting was called to order by current Chairman Todd Burns. The Chairman noted that the Meeting was being recorded for accuracy purposes and asked visitors to sign the attendance sheet.

Brookens as the Township representative to the Letterkenny Army Depot Restoration Advisory Board with the two remaining Board Members serving as alternates for the year 2021.

Brookens as the Township's voting delegate and Shawn M. Corwell as alternate voting delegate; and designate the mileage rate at the current IRS mileage rate at the time of the conference.
