
CAN YOU IDENTIFY THIS PICTURE?

COMPOSTING FACILITY TO REOPEN IN GREENE TOWNSHIP

Greene Township received a grant from the Pennsylvania Department of Environmental Protection. This grant was for the construction and management of a yard waste composting facility in Greene Township. The total amount of the grant was \$182,000 000. This money is to be used for equipment, design, operational design, and community education programs. The facility is now in operation and is located on Mickey Inn Road. The hours of operation are Saturday 8 AM to 4 PM. The facility will open October 9th and will remain open until further notice to accept discarded leaves, and brush (3" in diameter). The facility will be closed October 23rd because of bulk collection day. Later this year the site will be completed with the addition of a building and a fence. When the compost is ready, Township residents may come and take it home. The Township is not sure whether it will charge for the

We would like to remind the Township residents that the compost facility will not accept bulky items at the site. The Township sponsors a bulk collection day twice a year on Garver Lane in Scotland. The next one is October 23, 1999. The Compost facility will not be open on this date.


BULK COLLECTION DAY

Bulk collection day has been scheduled for Saturday, October 23, 1999. The collection will be at the Township building located a 1145 Garver Lane in the Village of Scotland The collection will begin promptly at 6:00 AM and will finish at 4:00 PM Items to be collected include: household appliances such a stoves, washers, dryers, refrigerators, water heaters, box springs, mattresses, microwaves, furniture, bicycles, and lawnmowers. In addition scrap iron, tin, metal, brass, and copper. Unacceptable items include batteries, pieces of batteries, gas tanks, tires, closed containers of any kind, motor oil, lumber, and any material considered hazardous. Items that are collected by regular refuse will also not be accepted.

Remember only Greene Township residents may take advantage of bulk collection day. Please have your driver's license ready when you come to the facility. Greene Township thanks you for your participation.

Pennsylvania's Census 2000

In the near future, you will be receiving by mail a package from the Census Bureau It is important that you fill this information out and return it to the Census Bureau by April 1, 2000 As a local leader, we are in the position to help make Census 2000 one of the most accurate and complete counts in history. By completing the census forms by next April, you're helping to better your community. How? One is just simply money.

Many state and federal programs are distributed to municipalities based on census figures. Federal programs include water and sewer projects, economic development and schools Pennsylvania programs that are census dependent include Liquid Fuels Fund, the Volunteer Firemen's Relief Fund and the Community Development Block grant (CDBG) program Franklin County receives Federal and State dollars for each person that lives in the County. The per capita amount received from the 1990 Census averaged \$577 00 per year over the past 10 years. It is estimated that since 1990, Pennsylvania has not received some \$210,000,000 in federal funds due to an estimated undercount of 35,000 people in the last census.

SNOW REMOVAL REMINDER

Please remember to help the Township help you during snow events this winter Please remember to park your cars off of the paved surface of the road Remove all obstructions from the cul-de-sacs so that the snow can be removed completely Section 3709 of the Pennsylvania Vehicle Code prohibits the placement of rubbish, glass, metal, trash, or any other substance dangerous of detrimental to the safety of the traveling public. This includes shoveling or plowing snow or ice onto the road right of way. Violators may be fined a maximum of \$300.00 per offense Please remain clear of the rear of the snowplows because of the salt and anti-skid that are dispersed. When removing snow from your driveways you may want to wait until the plows have completed their removal. Please remember that our snowplows stop and back up often. Please do not follow to closely or have your car where the operator cannot see you. If you can't see the snowplow's mirrors then the operator can't see you. During the snow events please stay off the roads unless it is absolutely necessary for you to be traveling.
