# GREENE TOWNSHIP PROVIDES ADDRESS SIGNS

The Greene Township Board of Supervisors is initiating the placement of reflective address signs throughout Greene Township. The Greene Township Board of Supervisors voted unanimously at their July 25, 2000 meeting to purchase these address signs for every address in Greene Township

The Board feels that poorly marked addresses in the Township are a significant public safety issue. At times emergency services personnel have a very difficult time responding to poorly marked addresses. That difference in response time could make the difference between life and death. We would like to provide one reflective address sign to every address in the township, free of charge. The address sign should be placed on the same side of the street as the corresponding home.

Greene Township's first due fire companies have agreed to administer the program for the Board of Supervisors. With proof of residence, any individual may pick up their reflective address sign at their first due fire company. They are as follows: Fayetteville Volunteer Fire Company, Main Street, Fayetteville, 352-3131; Pleasant Hall Volunteer Fire Company, 9722 Cumberland Highway, Pleasant Hall, 532-5155; West End Fire Department, Lurgan Avenue, Shippensburg, 532-5555; Franklin Fire Company, Corner of Franklin & King Streets, Chambersburg, 709-0633.

The 6' x 18' signs are 100% aluminum laminated with 3M engineer grade reflective vinyl.

### REMINDER FOR DOG AND CAT OWNERS

#### Dog and cat defecation and urination

- A. Nuisance defined. With respect to dogs and cats, a dog owner or cat owner shall be presumed to have created or maintained a nuisance if he shall permit his dog or cat to defecate or urinate:
- (1) Upon any street, sidewalk, passageway, park or any other public place where people congregate or walk; or
- (2) Upon any private property of another person without the permission of the owner of said property unless, with regard to defecation only, such dog owner or cat owner shall immediately remove and dispose of in a sanitary manner all feces deposited by such dog or cat
- B. Presumption. At the trial of any charge of violation of this section, if a dog or cat has defecated or urinated upon public or private property as hereinbefore set forth, it shall be conclusively presumed that the dog owner or cat owner has permitted the occurrence to have happened

#### Notice required.

- A. Method of serving notice. Prior to the filing of a private criminal complaint for violation of this article, it shall be necessary to serve written notice upon the dog owner or cat owner in one of the following ways:
  - (1) By mailing copy of the notice to the dog owner or cat owner by any form of mail requiring a receipt signed by the dog owner or cat owner or his agent;
  - (2) By personal delivery of the notice to the dog owner or cat owner;
- (3) By handing a copy of the notice at the residence of the dog owner or cat owner to an adult member of the family with which he resides; but if no adult member of the family is found, then to an adult person in charge of such residence; or
  - (4) By fixing a copy of the notice to the door at the entrance of the premises in violation
- B. Form to be provided. Notice required under this section must be given on a form prescribed and provided by the township and said required notice may be executed and served as required by the aggrieved party or by a township official on complaint received from the aggrieved party in writing and signed
- C. Content of notice. Notice shall set forth the name and address of the dog owner or cat owner; the nature and extent of the violation or offense; the identity of the person giving notice; the date of the sending or posting of notice; and a statement to the effect that a complaint may be filed if the nuisance is not abated within 24 hours of the time of receipt or posting of notice.
- D. Duration of notice. Any notice given pursuant to this section shall be valid for a period of six months; within six months, no additional notice need be given prior to the filing of a private complaint.

**Penalty**: Any person who violates or permits a violation of this article shall, upon being found liable therefor in a civil enforcement proceeding commenced by the township before a District Justice, pay a fine of not more than \$600, plus all court costs, including reasonable attorneys' fees, incurred by the township in the enforcement of this article. No judgment shall be imposed until the date of the determination of the violation by the District Justice. If the defendant neither pays nor timely appeals the judgment, the township may enforce the judgment pursuant to the applicable Rules of

**Civil Procedure**: Each day a violation exists shall constitute a separate offense. Further, the appropriate officers or agents of the township are hereby authorized to seek equitable relief, including injunction, to enforce compliance herewith.

**Enforcement**: The provisions of this article may be enforced by any person who, after prior notice is given as required, shall, as an affiant, institute a criminal proceeding by filing a complaint with the District Justice as provided by law.
