reene I ownship was established in 1788 and was named after Nathaniel Greene, a prominent general who served during the Revolutionary War It is governed by a three-member Board of Supervisors, elected for a term of six years. Currently, the Iownship employs an office staff of one full-time Supervisor, the Secretary/Treasurer, a Zoning Officer, an Assistant Zoning Officer and an Administrative Assistant, in addition to four full-time road workers that maintain 75 miles of Township roads The Township has a population of 12,678 and covers an area of approximately 59 square miles.

DID YOU KNOW?

- Open burning of any material with the exception of leaves, shrubbery, small tree limbs and garden refuse IS PROHIBITED under Greene Township Ordinance No 2 1990. This restriction is a result of the Pennsylvania State Law, Act 101 of 1988 which regulates the proper disposal of trash.
- Building permits are required for all new construction projects such as dwellings, mobile homes on private lots, both in-ground and above-ground swimming pools, additions, decks, porches, utility buildings, fences (over four feet high) and all other such structures
- Driveway permits, well permits and occupancy permits are now required for all new construction
- There is an ordinance prohibiting misances relating to dogs and cats on private and public property



athy makes her home at 8190 Nyesville Road, Chambersburg, with husband, Daniel, and two children, Steven, age 10, and Megan, age 6 She has faithfully and conscientiously served the residents of Greene Township as Tax Collector for ten years since 1987 She graduated Magna Cum Laude from Shippensburg State University in 1979 with a degree in accounting. While attending Shippensburg, she interned for three years as a CPA with a local tax office and upon graduation, continued her career with the same firm until her election as Township Tax Collector She offers the following tip for "Tax Peace of Mind": ALWAYS keep a copy of your real estate bills and payments for your records. You may need them for your income taxes, for refinancing, or when you decide to sell your home Additionally, did you know your neighbor may legally inquire about how much real estate taxes you pay? Yes, the real estate tax records are public information, so anyone may inquire about tax records and payments In fact, it's smart to inquire before purchasing a new home for budgetary reasons, or if you just constructed a new home and your home has been assessed for taxation, inquire about comparable homes in your neighborhood to assure your assessment is fair.
