The compost facility is now closed for the summer. The facility will re-open in the fall. Construction will soon begin on a building at the facility. This building will be for equipment and will house a small office. The facility will be paved hopefully when we re-open in the fall. A new grant application has been submitted by the Township for additional equipment to perform various chores at the facility. The Greene Township Board of Supervisors would like to thank the Township residents for their support of the facility. Hopefully next spring we will have compost to offer the Township residents. SUMMER PAVING PROJECTS

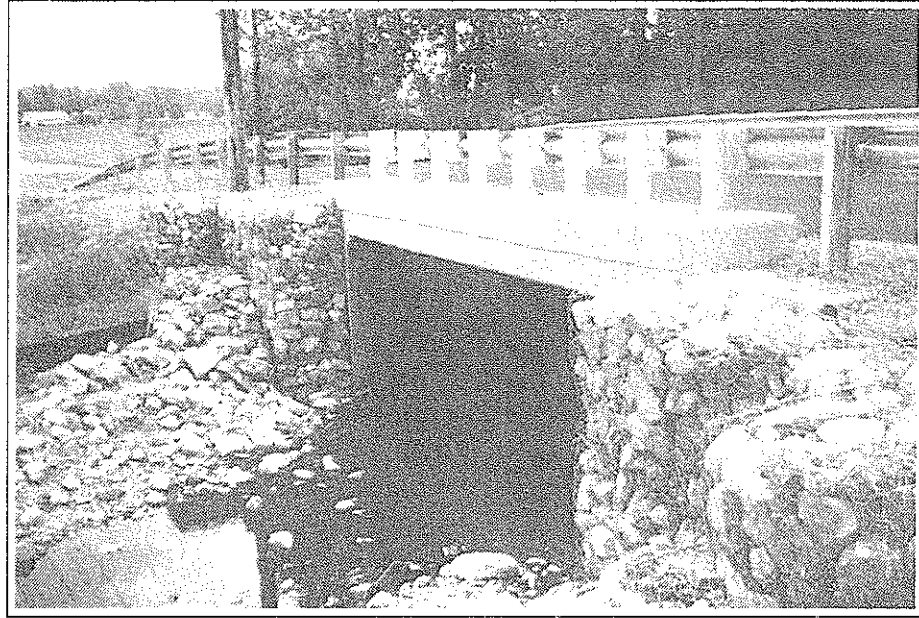
The Greene Township Board of Supervisors would like to advise its residents of the following road improvements that are scheduled for the summer of 1999. Construction has already begun on Funk Road. The road will be widened and repaved. The intersection of Salem Road and Rt. 11 is scheduled for repaving. The compost facility lot will be paved. Kohler Road is being prepared for repaving.

Please be prepared for delays during construction in these areas and you may want to seek alternative routes. The Board of Supervisors regrets any inconvenience during the construction. Please be alert for road crews and construction vehicles.

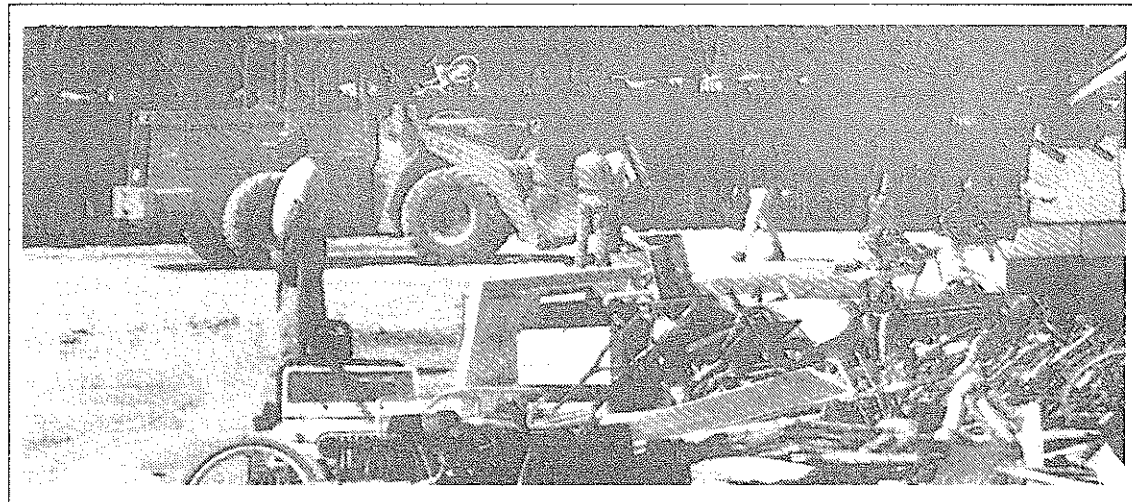

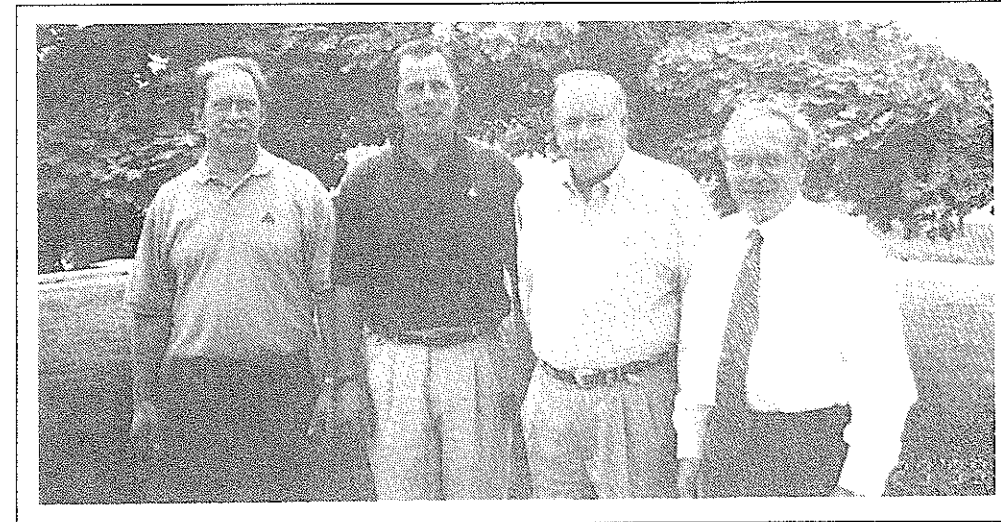


Another successful bulk collection day for residents occurred on April 24, 1999. The dumpsters were filled to overflowing once again as Greene Township residents threw away their bulk items. There were 468 vehicles that came to the Township property on Garver Lane in Scotland to discard various items. There were over 90 tons of bulk items discarded. 32 tons of metal waste went to Conservit of Hagerstown and over 60 tons was disposed of in the R & A Bender Landfill.

R&A Bender's landfill has been sold to IESI which is a Texas based firm. R & A Bender has had several different owners in the past two years. IESI plans to be a long term owner of this landfill and to be active in the community.



The Compost Facility pictured above is located on Mickey Inn Road between Scotland Main Street and Sycamore Grove Road. The facility is currently in operation accepting leaves, branches, and rubbish. The facility is not permitted by the Department of Environmental Protection to accept grass clippings. This facility will be paved this summer and a building will be added in the near future. A grant from the Department of Environmental Protection covered most of the cost for this facility. Greene Township is the only Township in Franklin County to operate a composting facility for its residents. The Board of Supervisors is happy to offer this service to the community.
